After calling the meeting to order, Judge Blanchette invited anyone offended by the court's practice of an invocation and pledge of allegiance to step out in the hall and return after the conclusion. The invocation was delivered by Jackie Skinner. The Pledge of Allegiance to the American Flag was led by Commissioner Marshall.

A motion was made by Commissioner Nash and seconded by Commissioner Marshall to accept the minutes of December 19 and December 31, 2018. All voted yes.

Commissioner Marshall made a motion to receive the monthly reports from the **Juvenile and Adult Probation Departments, County Clerk, District Clerk, County Treasurer, County Auditor and County Extension and Justice of Peace, Pct. #1. Commissioner Nash** seconded the motion. All voted yes and none no. SEE ATTACHED

Budget amendments/line item transfers, were not presented by the County Auditor.

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Nash** to approve the **county payroll**. Judge Blanchette asked the County Auditor if she anticipated what was proposed for payroll for 2019. She explained the county was under federal labor law that if employees worked, the county did not have an option not to pay. All voted yes and none no.

Judge Blanchette motioned to correct the appointment renewal for **Emergency Services District #2 (ESD#2)** from Henry Sawyer and Karl Hammond to Kozum Mott and Robert Perkins. Mr. Mott and Mr. Perkins terms will be January 1, 2019 to December 31, 2020. The motion was seconded by **Commissioner Marshall**. All voted yes and none no.

Commissioner Nash motioned to lease a replacement or upgrade copier for **Justice of the Peace, Pct. #1**. The motion was seconded by **Commissioner Marshall**. All voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Nash** to lease a copier for the **Criminal District Attorney's office**. All voted yes and none no. SEE ATTACHED

Commissioner Nash motioned to approve the lease for a 2018 CAT **motor grader** for **Road & Bridge Precinct #2**. **Commissioner Marshall** seconded the motion. All voted yes and none no. SEE ATTACHED

A motion was made by **Judge Blanchette** to approve the 2019 assignment of oversight by commissioners' court members for **county facilities and property**; and, the appointment of Commissioner Nash as **Judge Pro-Tem**. **Commissioner Marshall** seconded the motion. All voted yes with exception of Commissioner Nash abstaining from the vote for the Allen Shivers Library board. SEE ATTACHED

A motion was made **Commissioner Nash** and seconded by **Commissioner Marshall** to renew the **NETData IT support** for the period January 1, 2019 to December 31, 2020. All voted yes and none no. SEE ATTACHED

Judge Blanchette motioned to renew the county-wide annual imaging software maintenance for **RVI** for the period January 1, 2019 to December 31, 2020. The motion was seconded by **Commissioner Marshall**. All voted yes and none no. SEE ATTACHED

Commissioner Marshall motioned to purchase a 2015 Chevrolet 2500 pickup truck from the **Sheriff's office for Road & Bridge, Pct. #2**. **Commissioner Nash** seconded the motion. \$17,000 will be moved from Precinct #2 to general fund. All voted yes and none no.

A motion was made by **Commissioner Marshall** to lease/purchase a 2019 MACK truck tractor from Bruckner, Wichita Falls through HGAC for **Road & Bridge, Pct. #2**. **Judge Blanchette** seconded the motion. All voted yes and none no. SEE ATTACHED

A motion was made by **Judge Blanchette** to purchase a CPS belly dump trailer from Bruckner, Wichita Falls through HGAC for **Road & Bridge, Pct. #2**. **Commissioner Marshall** seconded the motion. All voted yes and none no. SEE ATTACHED

Commissioner Marshall motioned to lease/purchase a John Deere tractor with a tiger boom mower from George Bane Inc. through the Buy Board/ First National Bank Leasing, Wichita Falls, TX for **Road & Bridge, Pct. #2. Commissioner Nash.** All voted yes and none no. SEE ATTACHED.
