

Public Comment Participation Form


To make public comments either for or against a topic or item which may or may not appear on a Commissioners Court Agenda, individual(s) should be aware of the following:

- 1. This completed form must be submitted to the County Clerk prior to the start of Court!

 Public comments in Court will only be allowed at the designated place on the Agenda (unless a member of the Court requests otherwise).
- 2. Each individual will be limited to a maximum of five (5) minutes to address the Court. Maximum discussion on any Agenda item, regardless of the number of members of the public wishing to address the Court on any specific Agenda item (or items), shall be limited to thirty (30) minutes. In matters of exceptional interest to the Court, the Court, by a majority vote, may shorten or lengthen the time allocated for any or all Agenda items. Time for each speaker shall be maintained by the County Clerk or such other designated representative of the Commissioners Court.
- 3. Profane, insulting, or threatening language-directed toward the Court and/or any person in the Court's presence and/or racial, ethnic, or gender slurs or epithets will <u>not</u> be tolerated.
