

Our estimated fee to resurvey the courthouse square, picking up the building footprint and sidewalks, etc (no elevations or contours) would likely run between \$7800 and \$8500 plus any applicable tax.

We can accomplish this work roughly by the end of August, weather permitting. Deliverables will be a 24x36 plat of the property showing improvements and building footprint along with a surveyors report.

No underground utilities will be located, except by above ground evidence.
