Then 0.79 miles

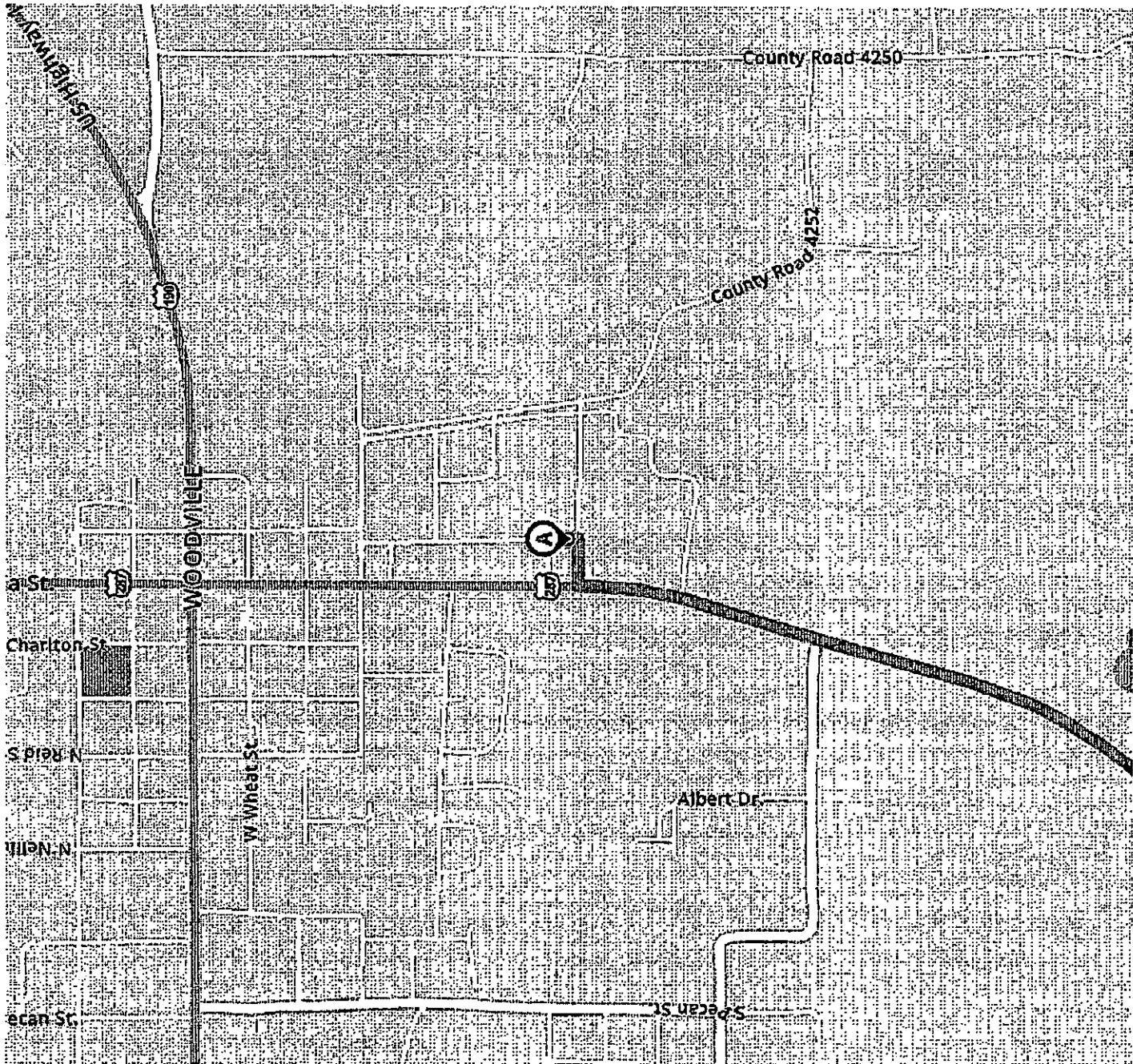
