#### TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM 2025-2026 APPLICATION CYCLE

The County of Tyler will hold a public hearing at 5:30 p.m. on Thursday, October 3, 2024, at the Tyler County Courthouse-Commissioners Court Room, located at 100 W Bluff Street Woodville, Texas 75979 regarding the submission of an application to the Texas Department of Agriculture for a Texas Community Development Block Grant Program (TxCDBG) grant. The purpose of this meeting is to allow citizens an opportunity to discuss the Citizen Participation Plan, the development of local housing and community development needs, the amount of TxCDBG funding available, all eligible TxCDBG activities, and the use of past TxCDBG funds. The County encourages citizens to participate in the development of this TxCDBG application and to make their views known at this public hearing. Citizens unable to attend this meeting may submit their views and proposals to Milton Powers, County Judge, at the County Courthouse. Persons with disabilities that wish to attend this meeting should contact the County Courthouse to arrange for assistance. Individuals who require auxiliary aides or services for this meeting should contact the County Courthouse at least two days before the meeting so that appropriate arrangements can be made. A member(s) of the public who completes a Public Comment Participation Form and submits it to the County Clerk prior to the CALL TO ORDER of the Court may offer remarks. Public Comment Participation Forms will be available prior to the start of court from the County Clerk or on the county website ([www.co.tyler.tx.us](http://www.co.tyler.tx.us)). Each member of the public who appears before the Commissioners Court shall be limited to a maximum of five (5) minutes to make his/her remarks.
