The meeting was called to order by Judge Powers. Commissioner Hughes led in the Pledge of Allegiance to the American flag and delivered the invocation.

## **CONSENT AGENDA:**

A motion was made by **Commissioner Hudson** and seconded by **Commissioner Marshall** to accept minutes from previous meetings: April 28<sup>th</sup>, May 12<sup>th</sup>, May 22 and June 9<sup>th</sup>, 2025. All commissioners voted yes and none no.

## PROCLAMATIONS/RESOLUTIONS/ORDERS:

A motion was made by Commissioner Marshall and seconded by Commissioner Blacksher to adopt the Resolutions for a 2025 Election Security Help America Vote ACT (HAVA) Sub-Grant. All commissioners voted yes and none no. SEE ATTACHED RESOLUTION

### CONSIDER/APPROVE/INFORMATIONAL:

A motion was made by **Commissioner Marshall** and seconded by **Commissioner Hudson** to renew the **iCrimeFighter Enterprise subscription** for 08/15/2025-08/15/2026. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Hudson** to renew the Election Systems & Software, LLC Service Contract. All commissioners voted yes and none no. SEE ATTACHED

A motion was made by **Commissioner Blacksher** and seconded by **Commissioner Hughes** to approve the Lease Agreement for the **Avgas Fuel Truck for October 2025 Air Show.** All commissioners voted yes and none no. SEE ATTACHED

Commissioner Marshall motioned to discuss and possibly take action on construction bids received on the GLO CDBG Regional State MID Projects, GLO Contract No. 24-065-046-E538. Commissioner Hughes seconded the motion. Bids were received from seven contractors. GLS recommended the low bid of \$1,881,275.45 from Texas Materials Group. A motion was made by Commissioner Blacksher and seconded by Commissioner Hudson to award the bid to Texas Materials Group, Jasper, TX for the GLO CDBG Regional State MID Projects, GLO Contract No. 24-065-046-E538[road improvements], as recommended by GLS. All commissioners voted yes and none no. SEE ATTACHED

The representative from GLS reported five contractor bids received for the GLO CDBG Regional State MID Projects GLO Contract No. 24-065-047-E539 for commissioner precincts #1, #2, #3, and #4. He further stated the grant funds available were \$7,597,532 with the proposed award totaling \$6,816,091.88. Commissioner Marshall motioned to award the bid packages #1 through #4 plus all additives associated with the packages, as recommended by GLS, to Texas Materials Group, Jasper, TX for the road work; and, bid package #5 for an emergency back-up generator for ESD#7 to Crockett Construction, as recommended by GLS. Commissioner Hudson seconded the motion. All commissioners voted yes and none no. SEE ATTACHED

# COMMENTS BY COURT MEMBERS PERTAINING TO MATTERS OF COUNTY GOVERNMENT:

Commissioner Blacksher- spoke to someone with Woodville school district about the potential acquisition of property beside JP office for parking lot and the gym for a shelter and a building for workforce development. Judge Powers had also spoken with someone to use the gym for a shelter and also for county events. He didn't think the county could share control of the building due to liabilities. Sondra Williams suggested a public use agreement. Judge Powers reported Colmesneil ISD had been the only school, and Woodville Methodist Church, to "open it's doors" to be used as a shelter. Commissioner Marshall added the need for first responders and utility workers need a place to stay. American Red Cross will provide food and cots.

**Judge Powers-** reported a \$350,000 grant available starting January 2026 for ambulance services. He recommended getting Sondra Williams to assist due to her knowledge of the services needed. Sondra stated Tyler County is considered a "roll-over" county. Tyler County does not pay subsidiaries and therefore a unit is not dedicated to Tyler County. **Commissioner Hudson-** stated a good thing and need to pursue, 'as long as everyone in your family is healthy no one thinks about it but when you have to make that call in a life-or-death situation then it hits home.'
