At the Special Meeting of the Tyler County Comm. Court held on the above date, all members were present as: Comm. Shepherd Pct. #1, Comm. Powell, Pct. #2, Comm. Fowler, Pct. #3 and Comm. Jordan, Pct. #4. Said meeting was presided over by Co Judge Jeff R Mooney with the following business being attended to:

Comm. Fowler made the motion, seconded by Comm. Shepherd to sign an agreement with the Bureau of Sport Fisheries and Wildlife cooperating with Texas Agricultural Extension Service. Tyler County shall pay toward the expense of The Texas Predatory Animal Control Ass'n., \$125.00 per month, for the period of six (6) months beginning Jan. 5, 1970. (COPY ATTACHED) Votes were as follows: FOR: Fowler, Shepherd, Powell
COMM. JORDAN did not vote.

Comm. Shepherd made the motion, seconded by Comm. Jordan that Vernon and Kenneth Best be allowed hanger space 40 ft by 80 ft, on the South side of the Tyler County Airport. All voted yes, none voted no.

Comm. Jordan made the motion, seconded by Comm. Powell to accept the application of the Tax Assessor-Collector for one (1) deputy at a proposed salary of \$255.00 per month, also to accept her deputation, Oath & Order. This position is to replace the vacancy by resignation of one deputy in his office. All voted yes, none voted no.

Motion was made by Comm. Shepherd to set the election hours from 8:00 A. M. until 7:00 P. M. Comm. Powell seconded this motion, and all voted yes, none voted no.

Comm. Fowler made the motion, seconded by Comm. Shepherd to set the Election Judges' salary at \$1.75 per hour and \$5.00 for bringing in the boxes. The clerk's salary were set at \$1.50 per hour. This is for the year 1970. All voted yes, none voted no.

Comm. Fowler made the motion to allow the County Judge to hire another custodian, with the salary for same being up to \$250.00 per month, beginning Jan. 21, 1970. Comm. Powell seconded this motion, and all voted yes, none voted no.

Motion was made by Comm. Sheperd, seconded by Comm Powell that \$1000.00 be paid to Longleaf Soil & Water Conservation out of Road & Bridge Funds. All voted yes, none voted no.

Comm. Fowler made the motion, seconded by Comm. Powell to allow the Sheriff's Dept to buy a new table and also allow purchase of a Check protector for the Co. Treas's office for \$159.50. (This \$159.50 is for the Check protector). All voted yes, none voted no.

Comm. Powell made motion to adjourn, seconded by Comm Fowler, with all voting yes; none voting no. THERE BEING NO FURTHER BUSINESS COURT ADJOURNED.
