 REGULAR SESSION

Comm. Fowler made the motion seconded by Comm Powell to pay all current bills that are approved by the County Auditor. All voted yes, none voted no.

Comm Jordan made the motion seconded by Comm Shepherd to accept the County Treasurer's report from April 1, 1970 through June 30, 1970. All voted yes, none voted no.

Motion was made by Comm Shepherd seconded by Comm Jordan to accept the resignation of Joe Parker as Constable of Pct #1. All voted yes, none voted no.

Comm Shepherd made the motion seconded by Comm Fowler to appoint Herman Nolen as Constable of Pct. #1. All voted yes, none no.

Motion made by Comm Powell (received no second) to appoint L. P. Hicks, Roy Peterson and Carl Fairchild to the Tyler County Hospital Board.

Comm Jordan made the motion seconded by Comm Fowler to table the motion to appoint L. P. Hicks, Roy Peterson and Carl Fairchild to the Tyler County Hospital Board at this time. All voted yes, none voted no.

Motion by Comm Fowler seconded by Comm Powell to approve a Radar Unit for the Highway Patrol Division. All voted yes, none voted no.

Motion made by Comm Jordan seconded by Comm Fowler to approve the bond of Carey Cruse to act as Probate Judge in place of Judge Jeff R. Mooney in probate case #4583. All voted yes, none voted no.

Motion made by Comm Fowler seconded by Comm Jordan to adjourn. Said meeting was adjourned until next meeting. All voted yes, none voted no.
