Comm. Shepherd made the motion, seconded by Mr. Powell to appoint L. P. Hicks, Roy Peterson and Carl Fairchild as Hospital Board members and to appoint Johnny Harris to replace the vacancy of Mr. Cecil Smith, as Hospital Board Member. All voted yes, none voted no.

Motion by Comm. Shepherd, seconded by Comm. Powell that the tax roll for 1970 as presented by Tax Coll. Tom Sawyer be approved. All voted was, none voted no.

Motion was made by Comm. Shephord, seconded by Comm. Jordan that the budget for 1971 as presented by Judge Mooney be approved. All voted yes, none voted no.

Motion was made by Comm. Shepherd, seconded by Comm. Powell to purchase from Robert A. Mann a tract of land containing 1.236 acres in the Jane Taylor League, Tyler County, Texas, and as consideration of same the County will convey a portion of the old roadway, known as Harmony Road, which amounts to 0.300 acres less that which the County wishes to acquire from Mr. Mann and plus that which the County wishes to acquire from Mr. Mann and plus and the County to agree to fence the old roadway so that cars cannot pass along it and to build him a fence along the new road which the County will acquire from him. All voted yes, none voted no.
