At the Regular Meeting of the Tyler County Commissioners Court held on the above date, all members were present. The meeting was opened with a prayer. Judge Tom D. Mann presided and the following business was attended to:

A motion was made by Comm. Best and seconded by Comm. Joran that the Court approve Deputation of Paulette Lee and that her salary be set at \$288.75 per month and that Grace Bostick be appointed Chief Deputy in County Clerk's office at a salary of \$317.69 per month. All voted yes, none voted no.

A motion made by Comm. Best and seconded by Comm. Jordan to approve bond of Verlee Belt, as Tax Assessor and Collector for Colmesneil Ind. School Dist. All voted yes, none voted no.

A motion was made by Comm. Best and Seconded by Comm. Jordan that all restrooms in the Courthouse be deordized if the price quoted is inclusive on all restrooms for a period of one year. All voted yes, none voted no.

A motion was made by Comm. Fowler and seconded by Comm. Parks that the following roads shall be discontinued as a County Road and relinquishes any and all rights that the County of Tyler may have by prescription or otherwise. Road between Lewon Fowler residence and Richardson residence from Farm Road 256 North to Willie Daniels and H.G. Sutton residence and Road from Allen Hays Cattle Guard west to the Billums Creek Bridge, known as the Sand Hill Road. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Jordan that the expenses of the County Judge and the Commissioners be paid by the County on a trip to Washington, D.C. concerning Solid Wase Disposal. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Fowler that no Welfare payments can be paid by the County without authorization by the Comm. in the Precinct affected. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks to pay all bills approved by the County Auditor. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks to advertise for bids to re-roof the Courthouse and to issue Time Warrants in payment thereof. Bids to be opened at 10:00 A.M. September 30, 1971.

There being no further business the meeting adjourned.
