A motion was made by Comm. Parks and seconded by Comm. Fowler that the Deputation for Carolyn Weeks Barnes be approved and salary be set at \$288.75 effective November 1, 1971. All voted yes, none voted no.

A motion was made by Comm. Fowler and seconded by Comm. Jordan that the reports of Clinton Currie and Mrs. Maurine Mooney be approved. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks to authorize the County Auditor to pay all approved bills. All voted yes, none voted no.

A motion was made by Comm. Jordan and Seconded by Comm. Parks that the County Auditor be authorized to attend the Auditors Conference in Austin and to pay his expenses. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks that County Clerk be authorized to attend with expenses paid the Vital Statistics Conference in Austin November 28 thru 30, 1971. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks that a section of road out of B.B. C., Abst. 141 be dedicated by Willis S. White and accepted by the County. See attached description. All voted yes, none voted no.

A motion was made by Comm. Fowler and seconded by Comm. Best that Comm. Fowler be authorized to purchase a truck from Buddy Ogden for use in Pct. #3. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks that the County advertise for and accept bids on a calculator for the Tax Office. All voted yes, none voted no.
