that the Tyler County Commissioners' Court
accept the provisions contained in Minute Order No. 65572 passed by the
State Highway Commission on Nov 5, 1971, for the improvement
by the Texas Highway Department of the roads described below and that Tyler
County agrees to furnish all required right-of-way free of cost to the State:

In TYLER COUNTY a FARM TO MARKET ROAD is hereby designated extend-
ing from end of F. M. Road 1532, 2.2 miles Southeast of F. M. Road
256, Southeast to U. S. Highway 69 at Doucette, a distance of ap-
proximately 3.2 miles, subject to the condition that Tyler County
will furnish all required right of way clear of obstructions and
free of cost to the State.

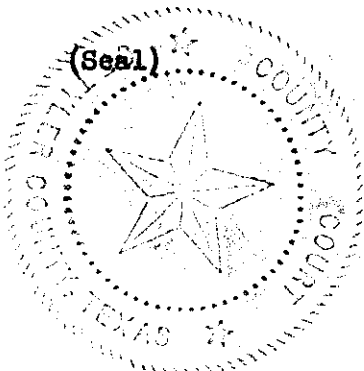

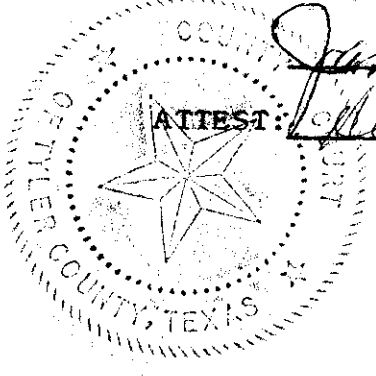

In TYLER COUNTY a FARM TO MARKET ROAD is hereby designated extending from end of F. M. Road 1532, 1.2 miles Southeast of F. M. Road 256, Southeast to U. S. Highway 69 at Loucette, a distance of approximately 3.2 miles, subject to the condition that Tyler County will furnish all required right of way clear of obstructions and free of cost to the State.

At such time as the County shall accept the provision of this Order and agree to the furnishing of the required right of way, the State Highway Engineer is directed to proceed with the engineering development, relocation assistance and construction of the project in the most feasible and economical manner, at an estimated cost of \$237,000, and to assume the road for State maintenance upon completion of the construction herein authorized.

This Order is subject to acceptance by the County and if not accepted within 90 days of the date hereof, the action herein contained shall be automatically cancelled.
