A motion was made by Comm. Best and seconded by Comm. Parks to accept the reports of Mrs. Mooney and Mr. Currie. All voted yes, none voted no.

The Court canvased the County Trustee returns and found them to be correct.

A motion was made by Comm. Fowler and seconded by Comm. Jordan to accept the bid of George P. Bane Company on refuse collection and sanitary landfill equipment. See attached bid. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks that the rate of assessment be increased a sufficient amount to pay for the time warrants which are to be issued to purchase the Solid Waste Equipment. All voted yes, none voted no.

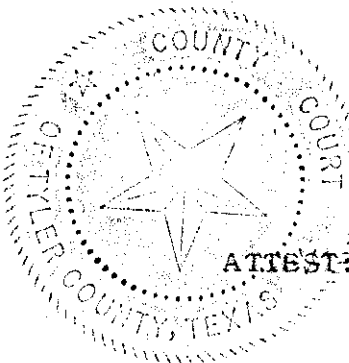
