A meeting of the Tyler County Commissioner's Court was held on the above date with Judge Mann presiding. Comm. Parks, and Comm. Jordan were present, and Comm Best and Comm. Fowler were absent. The Meeting was opened with a prayer.

A motion was made by Comm. Jordan and seconded by Comm. Parks. Since no bids were received to cover the materials for fencing the solid waste disposal area, that the court proceed to purchase necessary material at the best available price.

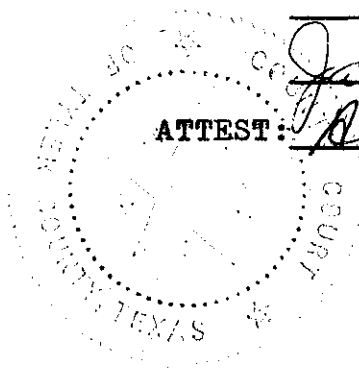
