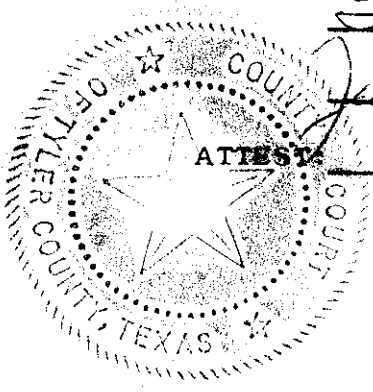

Dear Sir:

Tyler Road and Bridge Department here by authorizes you to construct facilities on the County right of way on all Roads in Tyler County (Chester Exchange).

1. Design of facilities shall be as follows:

Buried cable to be placed approximately 7 feet from right of way at an average of 30'' unless otherwise noted all crossing's on class A Roads must be bored. Only exception dirt roads.

2. Maintenance of facilities constructed here under shall be the responsibility of the grantee, and Tyler County reserves the right to require any changes, maintenance or repairs as may be necessary to provide protection or life or property on or adjacent to the R.O.W. at the expense of grantee. Changes in design will be made only with approval of the Tyler County Road and Bridge Department.

3. The grantee shall not erect any sign extending over any portion of the R.O.W.

4. The Tyler County Road and Bridge Department will assist as follows:

A. Inspection only

This permit shall not be valid until grantee signs the statement in which he agrees to comply with the conditions here in.

Mr. H M Parks should be contacted at least twenty four (24) hours before beginning the work arthorized by this permit.
