At the Meeting of the Tyler County Commissioner's Court held on the above date, all members were present and Judge Mann presided. The Meeting was opened with a prayer.

A motion was made by Comm. Parks and seconded by Comm. Best to approve the Bonds of the elected officials and the Deputation of Patsy Bradley as a Deputy in the Tax office. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Parks to set the number of employees in each office the same as they were in 1972. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Belt to raise the salary of each employee of the County \$25.00 per month with a limit of \$500.00 total salary per month for the road and bridge employees. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Jordan to give the Sheriff permission to have a window in the jail repaired. All voted yes, none voted no.

A motion was made by Judge Mann and seconded by Comm. Jordan to approve a \$25.00 automobile expense allowance per month for all elected officials. All voted yes, except Comm. Belt and he abstained.

A motion was made by Comm. Best and seconded by Comm. Jordan to declare the following days as official Holidays for the County:

All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks to set the Vacations and sick leave to be the same as last year being 2 weeks vacation a year and 2 weeks sick leave a year. Employees of less than 1 year get 1 week vacation. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks that Comm. Joe Best be appointed Airport Manager and Comm. Parks be Assistant Airport Manager. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Parks to approve Tyler County's share of the salaries of Valarie Pray as Court Reporter and Charlotte Hall as Secretary as Follows: Valarie Pray \$3,000.00 per year; Charlotte Hall \$150.00 Per month. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Best to appoint Judge Mann as Courthouse Manager. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Jordan to pay the Colmesneil, Fred, Woodville, Spurger and Chester Fire Departments \$25.00 per month each for rural fire Protection. All voted yes, none voted no.

The Court issued a call for all Inventories to be turned in prior to the February Meeting.

A motion was made by Comm. Jordan and seconded by Comm. Parks to set the terms of County Court as follows: January, April July and October. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Belt to set the Election hours from 8:00 A.M. to 7:00 P.M. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Jordan to advertize for Bids on gasoline, oil, fuel and antifreeze for the County and specifications to be listed in the Bid. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Best to deposit in each Commissioner's precinct Road and Bridge Fund \$5039.59 from the Revenue Sharing Funds. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Best to authorize Rois Brockman County Attorney to bring his Statutes up to date. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Belt to approve the cost of \$1.50 per meal to feed the prisoners. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks to approve the Deliquent Tax Contract with Wheat, Wheat & Stafford as submitted. All voted yes, none voted no.

A motion was made by Comm. Parks and Seconded by Comm. Jordan to approve the payment of all authorized bills. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks to approve the report of E.M. Pitts Veteran's officer and to pay the expenses as submitted. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Belt to authorize the Sheriff's Department to take bids on a new car with the specifications as set out by the attached copy. The Court reserves the right to reject any or all bids. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Belt to allocate the office space on the third floor previously occupied by the County Surveyor to the Welfare Department for an indefinite period of time. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks to approve the monthly reports of Mrs. Mooney and Mr. Curry. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Best to approve the Quartley Report as presented. See attached copy. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks to appoint a Grievance Committee with the members the same as last year. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Jordan to pay all of the elected officials on a salary basis except the Constables who will be paid on a fee basis according to the Statutes and that the resolution be certified and mailed to the Comptroller of Public Accounts of the State of Texas. All voted yes, none voted no.
