At the Meeting of the Tyler County Commissioner's Court held on the above date, all members were present and the Meeting was opened with a prayer.

A motion was made by Comm. Best and seconded by Comm. Parks to table the bids on Microfilm Equipment for the County Clerk for further study. See attached bid. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks to pay bills as presented by the Auditor and as approved by the Court. See attached list. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Jordan to require bids on any purchase concerning Revenue Sharing or County Funds when the cost of expenditures is over \$300.00. This is to include Capital expenditures only. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Belt to approve the signatures of Earl King and Ann Fondern to be used on the County Treasurer's office checks in absence of Mr. Fletcher Boyd. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Belt to approve the monthly reports of Mrs. Mooney and Mr. Currie. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Belt that since no bids were received on the Haliod Xerox machine that it be removed from the County Clerk's inventory and that it be stored in Comm. Pct.1 barn. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Belt to accept the bid of East Texas Paper Company, Lufkin, Texas, on Mimeograph paper (1) 200 reams 8½ X 11-#20 paper @ \$1.05 per ream and 200 reams 8½ X 14-#20 paper @ \$1.52 per ream (2) and to accept the bid of Story-Wright of Lufkin, Texas on 2 cases of 2½ inch adding machine paper @ \$16.50 per case and 2 cases of 3inch adding machine paper @ \$22.50 per case; and this to be delivered with no freight charge. All voted yes, none voted no.

Mr. Doyle Chandler from Chester, Texas, presented to the Court the plans for the City Park of Chester as of this date.

A motion was made by Comm. Best and seconded by Comm. Parks to approve payment of the bills as presented by the Auditor. See attached bids. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Best to accept the Plat of Woodland Hills for filing purposes only and to designate it as plat file 174. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Best to accept the bid of Fran-Mar Inc. to re-roof the Courthouse, and that Fran-Mar to post a Roofing bond and that Fran-Mar be responsible for removing all trash and waste materials from the Courthouse area. This contract is to be paid out of the Revenue Sharing money. See attached bid. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks to accept for filing purposes only the Plat of Magnolia Square on the Josiah Wheat Survey, Abstract 657 in the City of Woodville as plat file 175. All voted yes, none voted no.

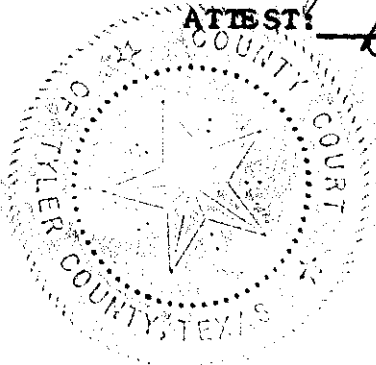

At your request I would like to submit my bid to install a new roof on the Tyler County Court House for \$8,980.00.


This bid includes the following items:

1. Spud off old roof and save rock that is suitable for new roof.
2. Apply a 20 year roof which is 2 ply of 15 pound felt nailed or glued. Mop on 3 ply with 300 to 400 pounds of roof gravel in hot steep pitch.
3. This roof is to comply with manufacturer specification.
4. Remove all damaged material from parphet wall and cover with fiberglas (Yellow Jacket).
5. Rework all coping.
6. Apply new materials on stack from boiler room.
7. Remove scuppers from rear of building or fire wall and install 2 new 3½" X 10" copper scuppers.
8. Remove vent to jail raise approximately 8" flash and counter flash.
9. Straighten and rehang to walls all down spouts.
10. After roof is complete we will have manufacturer to cut hole to get report on roof.
11. Contractor shall furnish certificate of insurance.
12. Pay local pervailing wages.
13. Draw ½ of contract when first 2 layers of roof are in place, balance upon completion of job.
14. 30 working days to complete contract.
15. Start 10 days after awarded job.





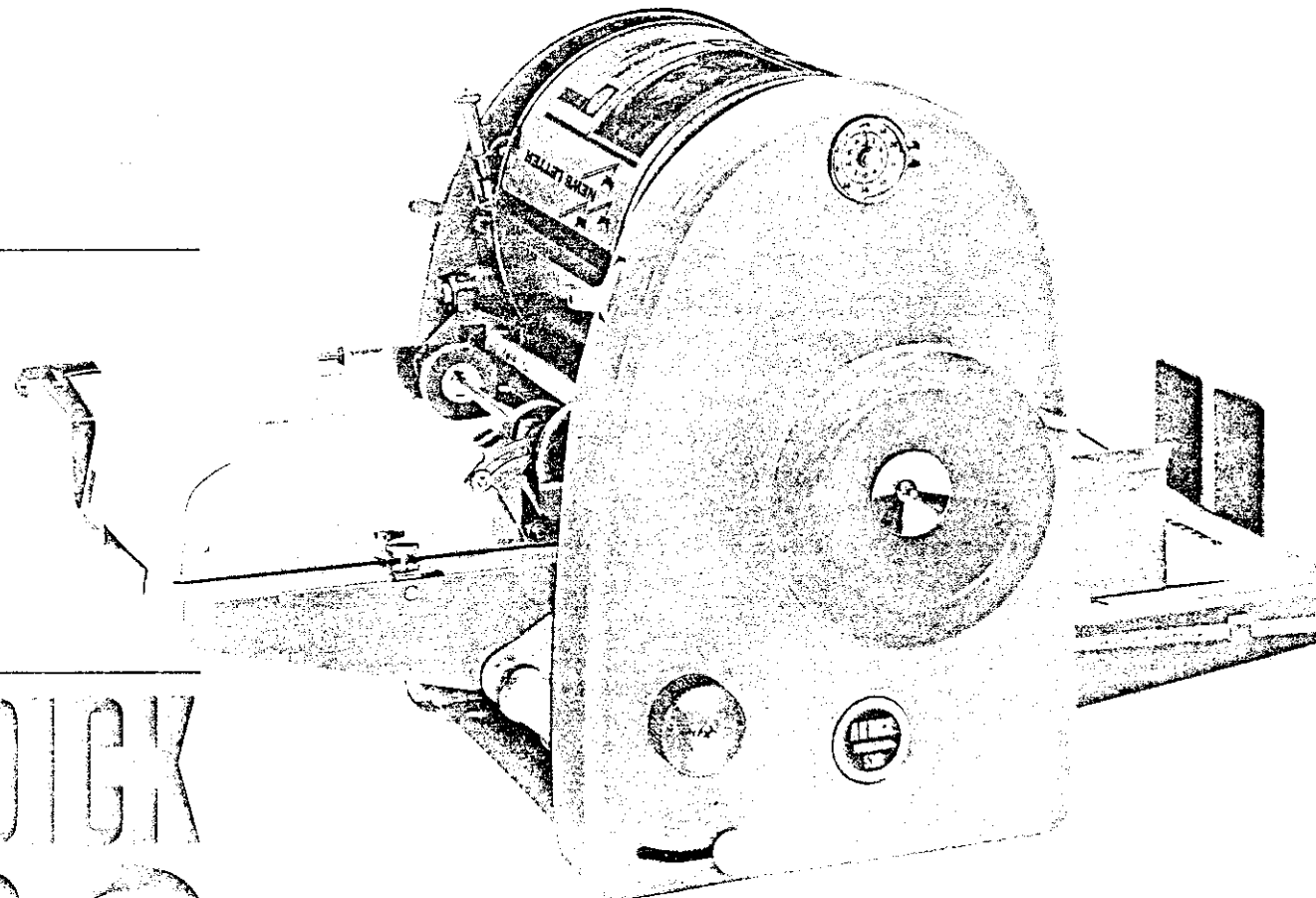
