At the Meeting of the Tyler County commissioners' Court held on the above date, all members were present. The Meeting was opened with a prayer.

A motion was made by Comm. Belt and seconded by Comm. Best to assign one of the positions allotted under the "Operation Mainstream" Program to the Tyler County Sheriff's office. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Best that the bid of A & M Motor Co. of \$3,975.00 for a Pontiac be accepted for a car for the Sheriff's office. The car that was ordered from Jack Lane Ford is not available at this time. See bid previously recorded in Vol, page 366. This is to be paid out of Revenue Sharing. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Belt for the County to advertize for bids on one road grader for Pct.#2 and one road grader for Pct.#3 and that Time Warrants will be issued to pay for same. Bids to be opened at 10:00 A.M. on the 30th day of April, 1973. ALL voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Belt to approve payment of up to \$50.00 per month to the Constables to be paid at \$.10 per mile and that they turn in a mileage report showing miles traveling in the performance of duty. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Jordan that the County Attorney be authorized to proceed with plans and specifications on remodeling of the County Clerk's office, the County Treasurer's office and the Probation office and that funds be allocation out of Revenue Sharing. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks that the Justice of Peace, Precinct 1 not be allowed a secretary and that she be used as a vacation relief if she so desires effective date is May 1, 1973. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Best to authorize the Sheriff's office to hire a Secretary effective May 1, 1973. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Belt to accept the "Operation Mainstream" allocation of four positions to be filled and assigned at a later date. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Jordan to record the results of the County School Trustee Election held on April 7, 1973 and the Canvass that shows the following:
Donald Tolbert-1 year unexpired term from Precinct 1
H.O. Seamans-2 year term from Precinct 2
L.P. Hicks-2 year term from Precinct 3.
All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Belt to approve the Cancellation Certificate as presented by the Tax Office. All voted yes, none voted no.

There being no further business the Meeting adjourned.
