A motion by Comm. Best and seconded by Comm. Belt to reject all bids submitted on the sale of the Sheriff's car. All voted yes, none voted no.

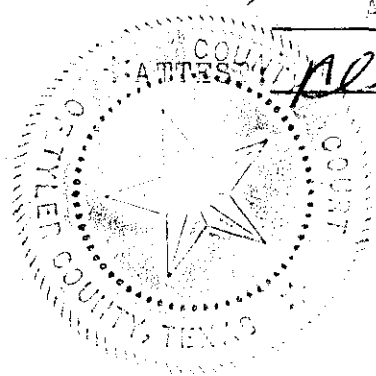

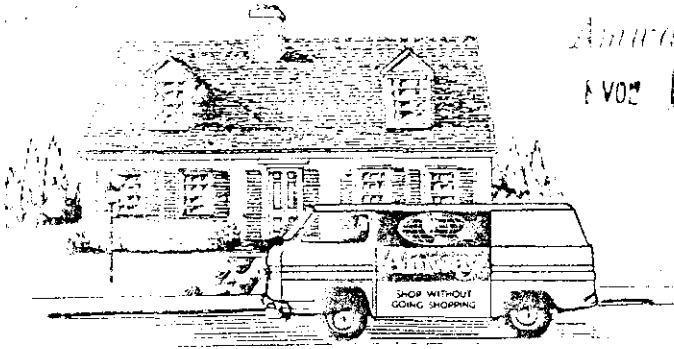

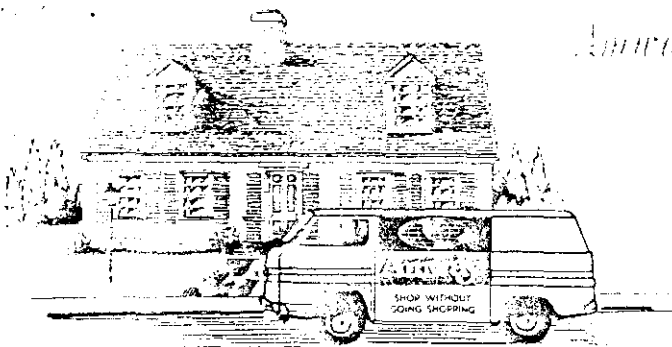
