A motion was made by Comm. Best and seconded by Comm. Belt to pay all monthly bills as submitted and approved by the County Auditor. See attached list. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Belt to approve the extension of the contract of Western Data Services, Inc. for the 1973 Tax Roll for another year. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks to accept the bid of Woody Berry to install a landscaping sprinkler system on the grounds of the Courthouse for \$2,975.00. This to be paid out of Revenue Sharing. Comm. Best and Comm. Parks for, Comm. Belt and Comm. Jordan against. Judge Mann for. The motion is carried.

A motion was made by Comm. Best and seconded by Comm. Parks to approve the monthly reports of the County Extension Office. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Parks to advertise for bids to have the airport mowed one time on a contract basis, not by the hour. Bids will be opened at 10:00 A.M. on June 25, 1973. See Judge's office for details. All voted yes, none voted no.

A motion was made by Comm. Jordan, and seconded by Comm. Parks to approve the color for painting the inside and outside of the Courthouse Manor White. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Best to approve the payment of premiums of Surety bonds and errors and omissions policies for the County Clerk's Office. All voted yes, none voted no.

A motion was made by Comm. Parks, and seconded by Comm. Belt to donate \$50.00 to the Tyler County Tourist for 1973. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Jordan to approve the purchase of an adding machine and installing an extension phone in the Sheriff's office. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Belt to grant permission and pay the expense of the County Clerk to attend the State Clerks Association Convention in Corpus Christi the last week in June. All voted yes, none voted no.

A motion was made by Comm. Parks and seconded by Comm. Best to loan Heritage Gardens the round desk and pay-out counter from the County Treasurer's Office, but the County will retain ownership. All voted yes, none voted no.

A motion was made by Comm. Best and seconded by Comm. Belt to reject all previous bids and to advertise for bids for a garbage truck. See County Judge's Office for specifications. Bids to be opened at 10:00 A.M., June 25, 1973. All voted yes, none voted no.

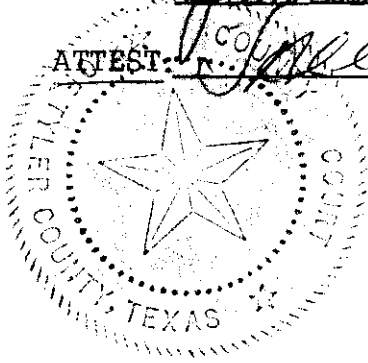
