In reference to the relocation of Sam Houston Electric Cooperative Inc.'s facilities inside the right-of-way of Recreational Road 255 in Tyler County, the following information is submitted.

Sam Houston Electric Cooperative, Inc. proposes to relocate those facilities inside Recreational Road 255 as discussed with Representatives of the Texas Highway Department on May 10,1974. This will be done at no expense to Tyler County for the work performed as this has been our policy over the years. It is unknown at the present as to how much longer Sam Houston Electric Cooperative, Inc. will be able to continue this policy.

However, the expenses involved in obtaining additional new right-of-way will be passed on to Tyler County for reimbursment. The exact amount of these expenses is unknown at the present, but Sam Houston Electric Cooperative, Inc. feels that the amount will not exceed \$1,500.00, as all easements except Southwestern Timber have been secured.

Sam Houston Electric Cooperative, Inc. is proceeding with the relocation as rapidly as possible to try to meet your July 1, 1974, date. However, if circumstances beyond our control delay us, Sam Houston Electric Cooperative, Inc. has never willing held up Contract Highway Work.
