At the Meeting of the Tyler County Commissioner's Court held on the above date, all members were present and the Meeting opened with a prayer.

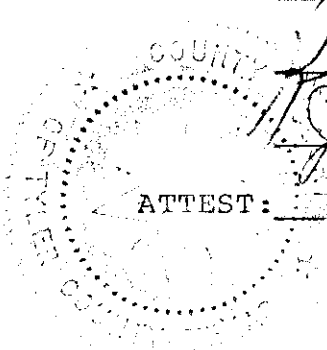
