At the Meeting of the Tyler County Commissioner's Court held on the above date and time, all members were present. The Meeting opened with a prayer.

A motion was made by Comm. Best and seconded by Comm. Belt to approve the bills as submitted by the Auditor's Office, excluding the bond bills. See the attached bills. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Belt to table the bill of Attorney McGaffey for defending Calvin Eason. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Parks to approve the report of the Extension Office. All voted yes, none voted no.

A motion was made by Comm. Jordan and seconded by Comm. Parks to pay our regular employees double when they work on holidays and to grant the dispatchers the same sick time as the rest of the employees, which is two weeks. All voted yes, none voted no.

A motion was made by Comm. Belt and seconded by Comm. Jordan to lease the rescue boat, which is owned by the County to the Tyler County Rescue Unit with the understanding that the Tyler County Rescue Unit will assume all liabilities and that the County Attorney will be asked to draw up a suitable lease. All voted yes, none voted no.

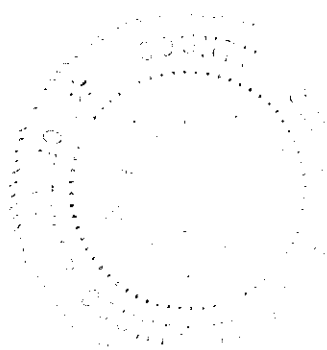
A motion was made by Judge Mann and seconded by Comm. Parks to allow \$50.00 for Robin Caraway. All voted yes, none voted no.
