At the meeting of the Tyler County Commissioner's Court held on the above date, all members were present. The meeting was opened with a prayer.

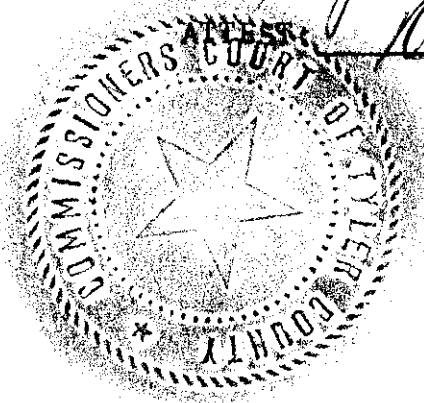

This work was done by James Robbins for the Texas Parks and Wildlife Commission. For: Best, Belt and Parks. Against: Jordan.

Motion was made by Commissioner Best and seconded by Commissioner Belt to authorize the County Auditor and the County Treasurer to disburse to James Robbins \$7,860.00 for the work done on the Sheffield Ferry boat ramp for the Texas Parks and Wildlife Commission. The money was paid to the County by the State for Mr. Robbins and was not taken from County funds. For: Best, Belt, and Parks. Against: Jordan.
