Attorney John Kinney presented a petition concerning the changing of Sunny Dell Road from Pct. #2 to Pct. #3.

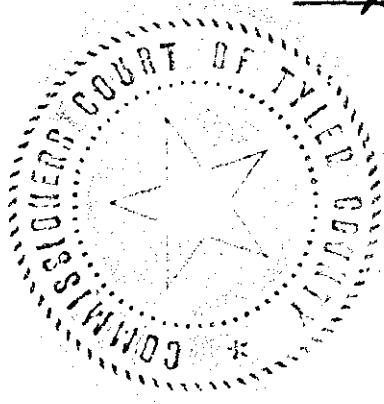
Comm. Parks made a motion which was seconded by Comm. Best, to table the question of the Petition for further study. All voted yes and none voted no. See attached Petition.
