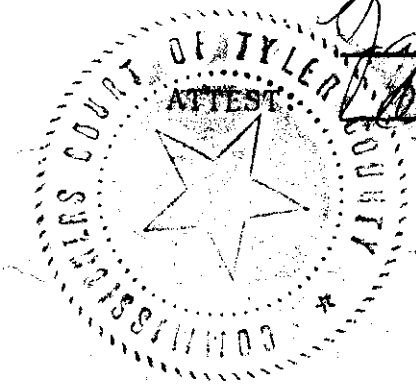
A Special Meeting of the Commissioner's Court met March 9, 1976 at 10:00 A.M. with all members present. The meeting opened with a prayer.
