A special meeting of the Tyler County Commissioner's Court met on Monday, June 28, 1976 at 9:00 A.M. All members were present and the meeting opened with a prayer.

Commissioner Parks made a motion which was seconded by Commissioner Best to approve the County Auditor's office, a secretary. The funds to pay this are in the budget. All voted yes and none voted no.

Commissioner Best made a motion which was seconded by Commissioner Fowler that all credit cards be turned in to the County Auditor to be docketed and then reissued to authorized personnel. All voted yes and none, no.

Commissioner Parks made a motion which was seconded by Commissioner Jordan to ask for bids to purchase paper for the County. Bids to be accepted until 9:00 A.M., July 19, 1976. All voted yes and none voted no.

Commissioner Parks made a motion to advertise for bids for mowing the airport one time. Bids to be opened at 9:00 A.M., July 19, 1976. This motion was seconded by Commissioner Best. All voted yes and none voted no.

Commissioner Parks made a motion which was seconded by Commissioner Fowler to advertise for sale the various old truck bodies and other used equipment. See the County Auditor's office for list and location of equipment for sale. Bids to be opened at 9:00 A.M., July 19, 1976. All voted yes and none voted no.

Commissioner Jordan made a motion which was seconded by Commissioner Best to advertise for a new car for the Sheriff's office with a trade in to be considered (1973 Pontiac). Bids to be accepted until 9:00 A.M., July 19, 1976 at which time they will be opened and considered. The County expects to pay cash out of Revenue Sharing if and when bid is accepted. Voting for were Commissioner's Fowler, Best and Jordan. Commissioner Parks, abstained. Motion passed.

There being no further business, the meeting was adjourned.
