A special meeting of the Tyler County Commissioner's Court met on Monday, July 26, 1976, at 9:00 A.M. with all members present. The meeting opened with a prayer.

Commissioner Fowler made a motion which was seconded by Commissioner Parks to table the question of the appointment of Election Judges until Friday, July 30, 1976, at 9:00 A.M. All voted yes and none, no.

Commissioner Parks made a motion which was seconded by Commissioner Best to request the Board of County and District Road indebtedness for the return of lateral road funds for Tyler County in the amount of \$28,193.70. This money is to be used on construction and improvement of lateral roads in Tyler County.

Meeting was recessed until Friday, July 30, 1976, at 9:00 A.M.

The Tyler County Commissioner's Court meeting continued Friday morning July 30, 1976 at 9:00 A.M. All members were present. The meeting opened with a prayer.

A motion was made by Commissioner Jordan and seconded by Commissioner Best to make Allen Sturrock a delegate to the Executive Committee of the Deep East Texas Council of Government. All voted yes and none voted no.

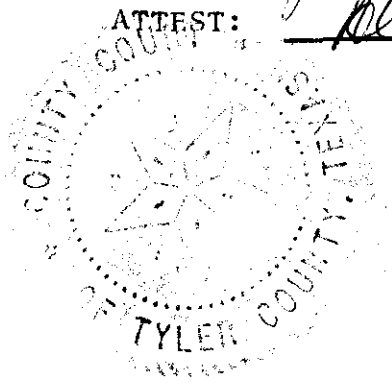
Commissioner Parks made a motion which was seconded by Commissioner Fowler to keep the same Election Judges as we had last year. All voted yes and none voted no.

There was a general agreement between the Commissioners that the Solid Waste be paid for out of the Revenue Sharing Fund.

The Commissioners then went into an executive session. There being no further business the meeting was adjourned.

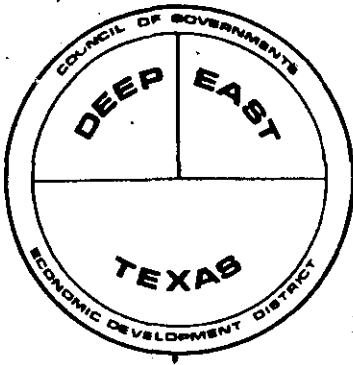
On September 1, we will credit your lateral road account with \$28,193.70 which represents your county's share of the Lateral Road Fund as of August 31.
