TYLER COUNTY COMMISSIONER'S COURT
 REGULAR MEETING
 October 11, 1976
 10:00 A. M.

The regular meeting of the Commissioner's Court met on Monday, October 11, 1976 at 10:00 A. M. The meeting was opened with Reverend David A. Hutchins representing the Ministerial Alliance leading the prayer. All members were present.

Commissioner Jordan made a motion to approve the County Treasurer's report. Commissioner Best seconded this motion. All voted yes and none voted no.

Commissioner Best made a motion to approve the County Extension report. Commissioner Fowler seconded this motion. All voted yes and none voted no.

Commissioner Best made a motion that the Entitlement Revenue Sharing Check #7 be budgeted as follows: Library - \$4,000.00; MHMR - \$1,766.25; R & B 1- \$4,112.68; R & B 2 - \$7,180.60; R & B 3- \$10,961.61; R & B 4- \$10,911.86. Commissioner Parks seconded this motion. All voted yes and none voted no.

Commissioner Best made a motion to divide R & B 1's part of the Revenue Sharing between Pct. 2 and 3 R & B fund. All voted yes and none voted no.

Commissioner Parks made a motion for the County to adopt the Resolution requesting the Texas State Highway Department to mark the city streets of Woodville as so requested by the City of Woodville. Commissioner Fowler seconded this motion. All voted yes and none voted no.

Commissioner Parks made a motion to pay the expenses for the Assistant County Auditor, Ann Fondren and secretary, Janie Crawford to go to Galveston for a seminar. Commissioner Best seconded this motion. All voted yes and none voted no.

Commissioner Best made a motion to table the payment on the Airport funds until Friday, October 15, 1976. Commissioner Parks seconded this motion. All voted yes and none voted no.

Commissioner Best made a motion to allow Mrs. Donald Hickman \$20.00 worth of groceries payable to Big Star. Commissioner Fowler seconded this motion. All voted yes and none voted no.

Commissioner Jordan made a motion to authorize Commissioner Fowler and Commissioner Parks to negotiate for the purchase of the rock pit in Rockland and make a recommendation to the Court Friday, October 15, 1976 for further action. Commissioner Best seconded this motion.

All voted yes and none voted no.

There being no further business, the meeting was adjourned.
