

TYLER COUNTY COMMISSIONER'S COURT  
SPECIAL MEETING  
January 3, 1977  
10:00 A.M.

The special meeting of the Commissioner's Court met on Monday, January 3, 1977 at 10:00 A.M. The meeting was opened with a prayer and all members present except Leon Fowler, Commissioner, Pct. #3.
