A special meeting of the Commissioner's Court met on Monday, January 31, 1977 at 10:00 A.M. The meeting was opened with a prayer by Comm. James Robert Jordan with all members present.

Commissioner Jordan made a motion approving payment of \$10,790.00 to Regional Probation Department, as per budget. The balance due to be paid after a conference with Probation Department. Comm. Lowe seconded this motion. All voted yes and none voted no.

Commissioner Riley made a motion approving the filing of plats for Wildwood. Comm. Fowler seconded this motion. All voted yes and none voted no.

Commissioner Lowe made a motion to approve Commissioners and County Judge to attend a conference at A & M, College Station, Texas, Feb. 1, 2, & 3, 1977. Comm. Riley seconded this motion. All voted yes and none voted no.

Commissioner Riley made a motion to approve Ricky Thompson as Court Reporter for District Court of the 88th Judicial District. This will be at salary fixed, attached. Effective as of today. Comm. Fowler seconded this motion. All voted yes and none voted no.
