Commissioner's Court in Session

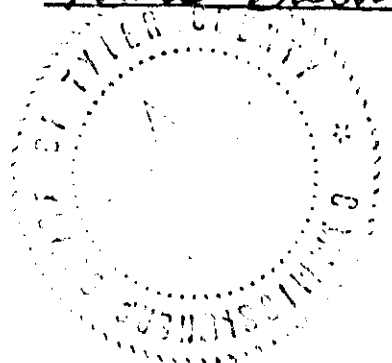
