A Special Meeting of the Commissioner's Court met on Monday July 18, 1977 at 10:00 A.M. All members being present.

A motion was made by Commissioner Jordan and seconded by Comm. Riley to accept Bids for a car for the Sheriff's Department, and Bids to be opened August 2, 1977. Each Dealer in Tyler County will receive Specifications. All voted yes and none no. See Attached Specifications.

The approval of paying monthly bills was made by a motion from Comm. Fowler and seconded by Comm. Jordan. See attached. All voted yes and none no.

A motion was made by Comm. Jordan and seconded by Comm./to accept the Bid on H.U.D. Project from Dixie Materials, Inc. pending negotiation Contract. See attached. All voted yes and none no.
