A motion was made by Comm. Riley and seconded by Comm. Lowe to recess until 11:30 A.M. in order for the Commissioner's to attend the Groundbreaking of Levingston Shipbuilders, Inc.

Commissioner Riley made a motion that was seconded by Comm. Jordan, to enter into a Pre-application contract with Semetko and Waxman, Inc. for Community Development Block Grant Funds, for the year 1978. See attached Contract.
