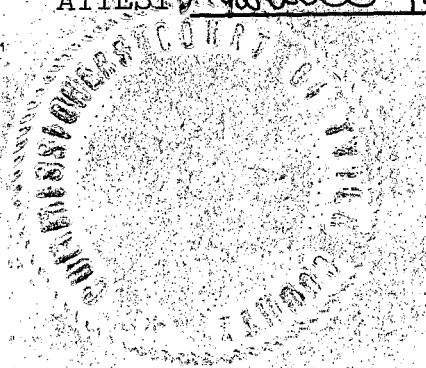
A motion was made by Commissioner Fowler and seconded by Commissioner Lowe to table and set date for discussion on Policy at County Dump. All voted yes and none no.
