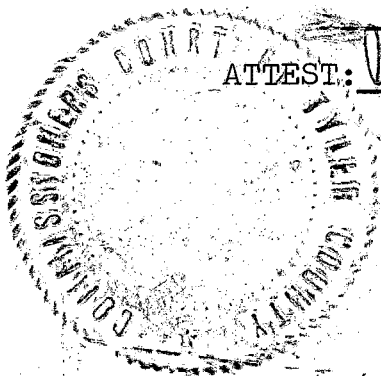

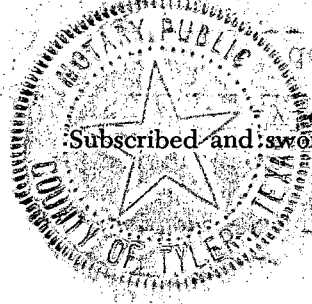

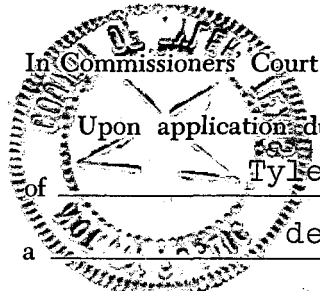

ORDER AUTHORIZING APPOINTMENT OF DEPUTY



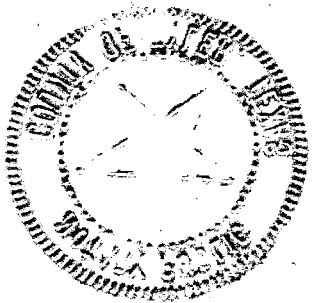
In Commissioners Court of Tyler County, Texas.
