An Emergency Meeting of the Commissioner's Court, met on Thursday October 26, 1978 at 10:00 A.M. All members being present except Commissioner James R. Jordan. The meeting was opened with prayer by County Judge Allen Sturrock.

A motion was made by Commissioner Riley and seconded by Commissioner Lowe to accept the request of Atty. John Ross Kay representing Mont Neches Lake Estates, to terminate the public designation of two public roads, being described in the Resolution attached. All voted yes and none no.

A motion was made by Commissioner Lowe and seconded by Comm. Fowler to Declare Emergency to purchase a Trailer for Pct. #2 to be used to haul Equipment. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Comm. Lowe for Commissioner Fowler to be given the authority to proceed with the purchasing of ROW on highway 92. All voted yes and none no. The purchasing of ROW for highway 69 was discussed but no action was made.

There being no further business, the meeting adjourned.

RESOLUTION

The Commissioner's Court of Tyler County met in special session on the 26th day of October, 1978 and the following Resolution was presented to the Court:

WHEREAS, more than eight (8) free holders of Commissioner's Precinct No. 4, Tyler County, Texas, petitioned this Court to discontinue two (2) county roads in Commissioner's Precinct No. 4; and

WHEREAS, it appearing to the Commissioner's Court that said petition has been posted for more than twenty (20) days, both at the location of the roads and at the door of the County Courthouse; and

WHEREAS, said petition was published for three (3) consecutive weeks in the Tyler County Booster; and

WHEREAS all requirements of Article 6705, Revised Civil Statutes of Texas, have been met;

BE IT THEREFORE now resolved that the Commissioner's Court of Tyler County does hereby terminate the public designation of two (2) public roads, said roads being described as follows:

- See Exhibit "A" for the description of that road known as Bluff Road.
- See Exhibit "B" for the description of Chimene Road.

The above Resolution was duly read and discussed and upon a motion by Commissioner Riley and seconded by Commissioner Lowe, the Resolution was given for vote.
