A motion was made by Commissioner Riley and seconded by Commissioner Lowe to table and study the Tyler County, Texas Annual Report, until Friday March 16, 1979. All voted yes and none no.

A motion was made by Commissioner Odom, and seconded by Commissioner Riley to table and study the request of Melinda Stryker, for Aid for foster children. All voted yes, and none no.

A motion was made by Commissioner Lowe and seconded by Commissioner Odom to approve the County Extension Monthly Report, as submitted by their Office. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Odom to approve the County Treasurers monthly report as submitted. All voted yes and none no. See attached.

A motion was made by Commissioner Riley and seconded by Commissioner Odom, to select by random drawing, from the 1978 Grand Jury List, an additional Grievence Committee. 

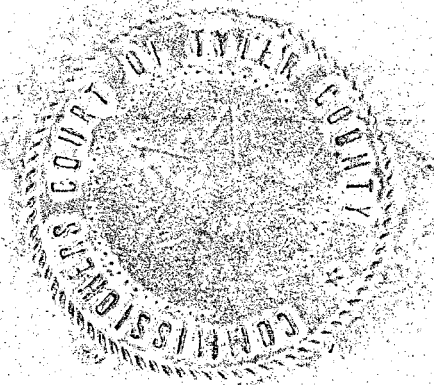

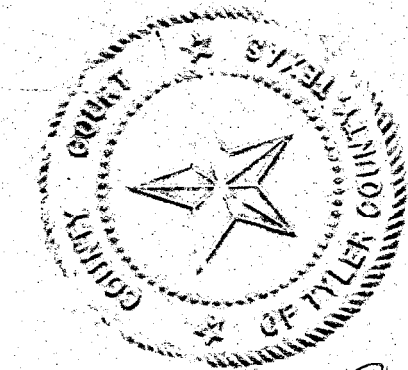
