Mrs. Washburn, Director of Home Services for Tyler County, gave a good discussion on Foster Children of Tyler County, and the Court considered the Bills for payment, for these children.

A motion was made by Commissioner Lowe and seconded by Commissioner Odom, to table and study the request for a machine for the Office of Tax-Assessor Collector, Barbara Tolbert. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Odom to approve the payment of Bills for the County, for the month of September, as submitted by County Auditor Ann Fondren, with an admendment as she requested. All voted yes and none no. See attached.

A motion was made by Commissioner Riley and seconded by Commissioner Lowe to approve the County Extension Monthly Report, as submitted by County Agent, Clinton Currie. All voted yes and none no.

A motion was made by Commissioner Odom and seconded by Commissioner Lowe to table the discussion of Termites, in the Courthouse, until the next regular meeting, November 13, 1979. All voted yes and none no.

A motion was made by Commissioner Odom and seconded by Commissioner Riley to nominate Jerry Grimes as its member to the Tyler County Appraisal Board. All voted yes and none no, with Commissioner Fowler absent and not voting. This is SB 621.

A motion was made by Commissioner Riley and seconded by Commissioner Lowe for the County Attorney, Rois Brockman, to have the authority to determine the legality of a Plat submitted by Mr. Duff of Austin, Texas, on a Warren Road. All voted yes and none no.

There being no further business, the meeting adjourned.
