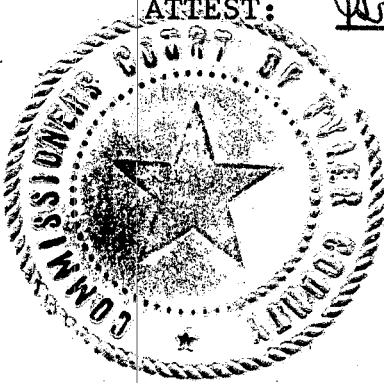

Commissioner Odom made a motion for the County to advertise for the issuance of time warrants to be issued for the construction of the Turkey Creek Bridge and the Lake Hyatt Bridge, in the amount of \$ 60,000.00. The motion was seconded by Commissioner Riley. These are to be paid off when the funds are received from the Disaster Fund. The final time warrant will be paid off June 1, 1980. All voted yes and none no.
