DECEMBER 18, 1981

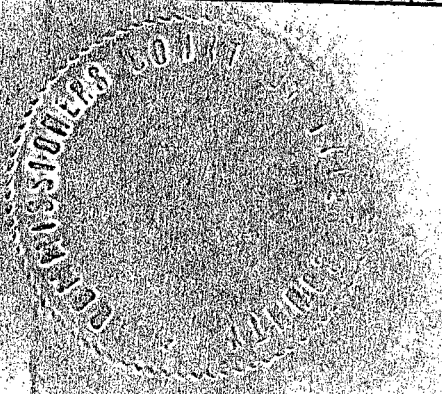
