A Special Meeting of the Commissioner's Court, met on Friday January 15, 1982 at 10:00 A.M. All members being present except Commissioner Odom. The meeting was opened with prayer by County Judge Allen Sturrock.

A motion was made by Commissioner Riley and seconded by Commissioner Lowe to accept the bid of Knapp Ford Sales, Inc. This vehicle was for the Sheriff's Department. The bid for the amount of \$9,491.00. Another bid from Allison Chevrolet, Inc. for \$9,795.00 was presented. There was no Trade-in on the bids. All voted yes except Commissioner Mahan, who voted NO. Bids attached.

A motion was made by Commissioner Riley and seconded by Commissioner Mahan agreeing to underwrite the construction of the Base Station and Tower for the Tyler County Firearms association. (Application has been made to Temple Foundation for fund funds to help construct this.) If Temple Foundation doesn't take care of the remaining cost, then the County will pick up the remaining cost. All voted yes and none no.

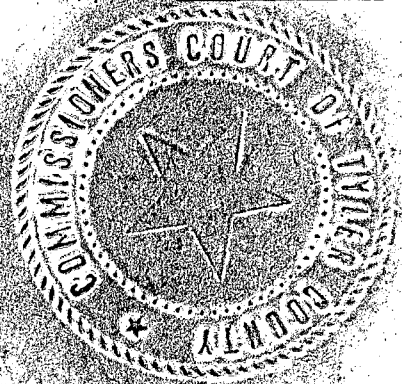



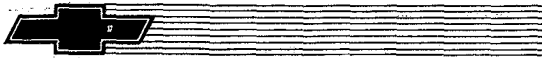
