SPECIAL MEETING
MARCH 1, 1982

A Special Meeting of the Commissioners Court, met on Monday, March 1, 1982 at 4:00 P.M. All members being present. The meeting was opened with prayer by County Judge Allen Sturrock.

A motion was made by Commissioner Odom and seconded by Commissioner Lowe to buy 5 Storage Cabinets, No. 1715. Then 15 Cabinets #C, with an extra shelf for each of these. See attached catalog picture. These Cabinets to be placed in the Basement of the Courthouse, after the tentative agreement of clearing out the basement, painting it, placing good lights, and doing what needs to be done in order to preserve the records, that are there. All voted yes and none no. A motion was made by Commissioner Lowe and seconded by Commissioner Odom for the Tyler County Historical Society to have priority over these records, after the Court has made a decision as to what is required from the Statues of the State. This will also include records from all offices. All voted yes and none no.

A motion was made by Commissioner Riley and seconded by Commissioner Odom to accept the bid of Sanderson Home Improvements Woodville, Texas 75979, for cleaning and painting of different offices in the Courthouse, including the Domino Hall. All voted yes and none no. See Bids attached. Mr. Sanders will first wash the Domino Hall and there will be an option, as to the painting.

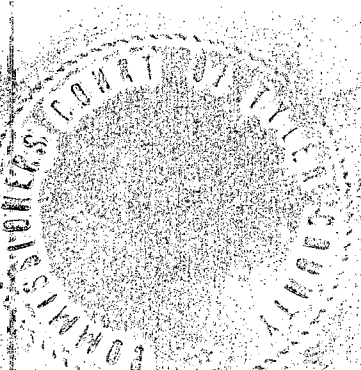

There being no further business, the meeting adjourned.

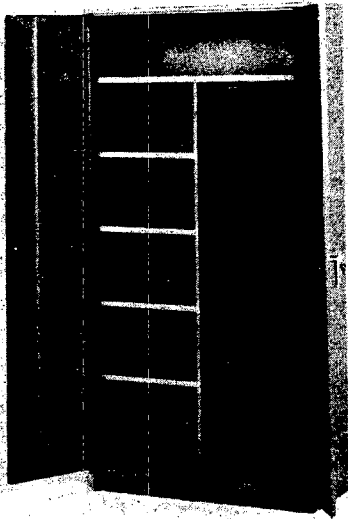
