A Special Meeting of the Commissioner's Court, met on Tuesday October 19, 1982 at 10:00 A.M. All members being present. The meeting was opened with prayer by County Judge Allen Sturrock.

A motion was made by Commissioner Mahan and seconded by Commissioner Riley to cancel the Contract on Lease Purchase Plan between Tyler County and NCR for one NCR Computer #8150, for the following reasons: All voted yes and none no, on this.

- 1. Two years of documented problems, software & hardware.

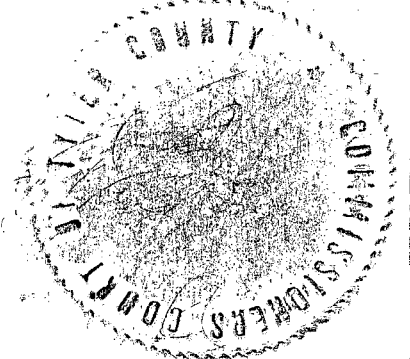
The latest, dated October 11, 1982, occurred when the Daily Expense & Revenue Transaction Report was printed. Several receipts show up two and three times. A receipt can be entered only once. Machine will not accept receipt the second, much less the third time. I can delete one receipt but the others remain in the system. This problem could probably be corrected in time, but, after looking at the machines track record, other problems would continually occur.

- 2. I was told by the salesman, he was given instructions by his superiors, to spend no more time with Tyler County's problems. This lead me to believe NCR is not concerned about standing behind the systems they have sold. A Systems Engineer was sent from Dallas at \$65.00 an hour, plus expenses. He studied the program for three hours and then admitted he wasn't familiar enough to do any more constructive work. He returned to Dallas to study the problems from there.

- 3. I have tried three software programs on the 8150 in two and one-half years. One program was actually installed twice. There has never been a time when the system operated smoothly. Complete documentation is available to uphold this claim.

There being no further business, the meeting adjourned.


