### TYLER COUNTY CRIMINAL DISTRICT ATTORNEY

(a). The constitutional office of criminal district attorney of Tyler County is created.

(b) The criminal district attorney shall possess all the qualifications, take the oath of office, and give the bond required of district attorneys by the constitution and general laws of this state. The criminal district attorney shall reside in Tyler County during his term of office.

(c) It is the duty of the criminal district attorney or his assistants to be in attendance on each term and all sessions of the district courts in Tyler County and all sessions and terms of the inferior courts of Tyler County held for the transaction of criminal business and exclusively to represent the State of Texas in all criminal matters pending before those courts and perform such other duties as may be conferred by law on the district and county attorneys in the various counties and judicial districts of this state. The criminal distirct attorney shall collect the fees, commissions, and perquisites that are provided by law for similar services rendered by district and county attorneys of this state.

(d) The criminal district attorney shall be commissioned by the governor and shall receive an annual salary from the state, to be paid by the comptroller of public accounts in equal monthly installments, in an amount equal to the amount paid district attorneys by the state, as appropriated by the legislature. In addition, the commissioners court may, in its discretion, supplement the salary paid by the state.

(e) The criminal district attorney may appoint the staff required for the proper and efficient operation and administration of the office, as provided by general law.

(f) On the effective date of this Act, the Governor shall appoint a criminal district attorney of Tyler County, who shall hold office until the next general election and until a successor is elected and has qualified. At the general election in 1984 and every four years thereafter, this officer shall be elected to a regular four-year term as provided by Article XVI, Section 65, of the Texas Constitution. A vacancy occurring in the office of the criminal district attorney of Tyler County shall be filled by appointment by the governor, and the appointee shall hold office until the next general election and until a successor is elected and has qualified.

(g) The office of county attorney of Tyler County is abolished.

(h) From and after the effective date of this Act, the district attorney of the 88th Judicial District shall continue to fulfill the duties of the district attorney in the county of Hardin, but his duties in the County of Tyler are divested from him and invested in the criminal district attorney of Tyler County. From and after the effective date of this Act, the district attorney of the 88th Judicial District shall be elected only from the county of Hardin.

(i) That the acting county attorney of Tyler County shall hereby serve as the acting criminal district attorney of Tyler County until the next general election in 1984.

(j) The newly created criminal district attorney of Tyler County is hereby permitted to actively engage in the private practice of law.




