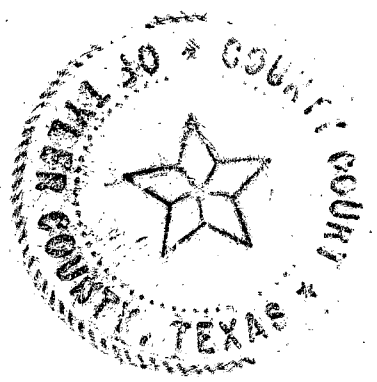
IN SESSION:

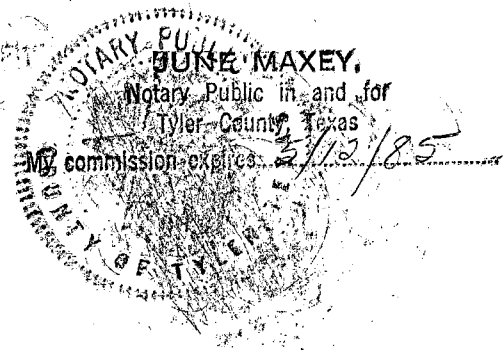


