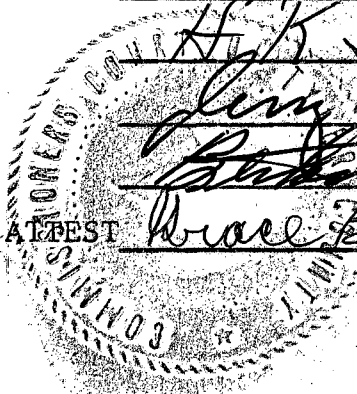
1. Kennedy and Company, Houston, Texas.

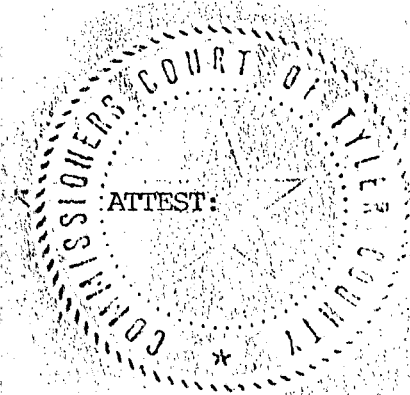
