An Emergency Meeting of the Commissioner's Court met on Monday, February 27, 1984, at 10:00 A. M. All members being present. The meeting was opened with prayer by Commissioner James R. Jordan.

Members of Commissioners Court discussed a problem presented to them by Pct. #4 Commissioner James R. Jordan, concerning the cause of water flooding over a County Road located near Spurger, Texas. A levee, built by Woodrow W. Hicks, to control water flow on his property, is alleged to be the cause of the problem. Since the advice of County Attorney Patrick Hardy was needed and he was unable to be at the meeting at this time, Judge Allen Sturrock called for a recess.

Commissioners Court now in session, with Pct. #3 Commissioner Jerry Mahan being absent. County Attorney Patrick Hardy still unable to attend the meeting. After a short discussion concerning the above mentioned problem, Judge Allen Sturrock called for a recess.

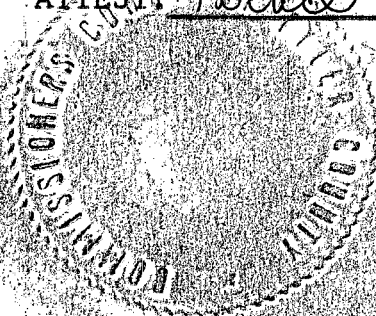
RECESSED UNTIL 11:30 A. M.

At this time, Commissioner Jordan made a motion to file an injunction against Woodrow W. Hicks, to try to persuade Mr. Hicks to destroy the levee. This motion was seconded by Commissioner Lowe. All voted yes and none no.




