ORDER ASSIGNING BOND ALLOCATION

WHEREAS, by resolution dated December 10, 1984, the Industrial Financing Corporation of Tyler County, Texas (the "Issuer") has provided for the issuance of the Issuer's Industrial Development Revenue Bonds (E. & L. Lumber Co., Inc. Project) Series 1984 in the amount of \$4,000,000.00; and


WHEREAS, this Commissioner's Court, by order dated December 10, 1984, has proved the issuance of such bonds; and

WHEREAS, this County has requested a portion of the "private activity bond" allocations set aside for the State of Texas, as provided in the Deficit Reduction Act of 1984, under the procedures provided in Executive Order MW-27A issued by the governor of the State of Texas; and

WHEREAS, to accomplish the issuance of the above described bonds as provided in the previous resolution of the Issuer and the previous order of this Court, it will be necessary for this County to assign to the Issuer its allocation for the bonds;

Lumber Co., Inc. Project) Series 1984 in the amount of \$4,000,000.00 be, and the same is hereby, assigned to the Industrial Financing Corporation of Tyler County, Texas.

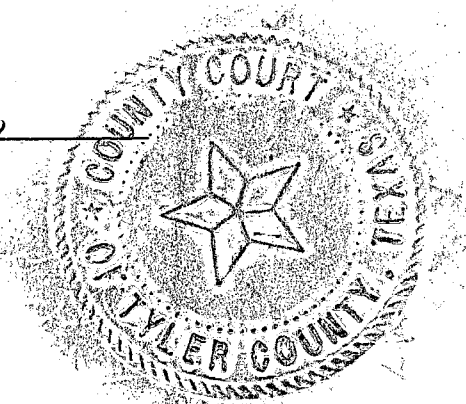

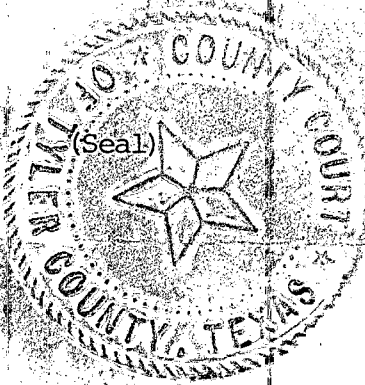

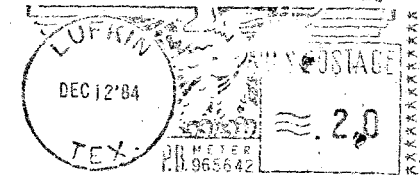
