A motion was made by Commissioner Riley and seconded by Commissioner Lowe to approve paying monthly bills for the County, as submitted by County Auditor Ann Fondren. All voted yes and none no. See Attached.

Billy Percival, District 9 Director, County Extension Service, from Overton, Texas, met with Commissioner's Court to introduce Robert David Armentrout to the Court members, and to recommend Mr. Armentrout for the position of Tyler County Extension Agent, replacing Clinton R. Currie, recently retired. After discussing the matter, and since this item was not on the agenda for the day, Judge Sturrock asked the members of the Court to make a motion to accept Mr. Percival's recommendation; also, that the matter would be on the agenda for the next regular meeting. At this time, a motion was made by Commissioner Riley and seconded by Commissioner Jordan to give their tentative approval of this recommendation, with April 1, 1985, the effective date for Mr. Armentrout to assume his duties. All voted yes and none no.

There being no further business, the meeting adjourned.
